ORDINANCE No. 001 OF 2017

(July 14)

"BY MEANS OF WHICH IT IS SOUGHT TO AVOID COCONUT SHORTAGES ON THE ISLAND AND GUARANTEE THE PREVAILANCE OF TRADICIONAL GASTRONOMIC PRACTICES IN THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, OLD PROVIDENCE AND KETHLEENA".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the article 300 of the Political Constitution of Colombia, and in concordance to Law 47 of 1993, and Law 915 of 2004; and Ordinance 005 of June 11 of 2009.

ORDERS

ARTICLE 1. To prohibit the use of coconut as a other presentation in which the fruit can be used.

ARTICLE 2. The Secretariat of Agriculture and Fishing will oversee the compliance of this ordinance.

PARAGRAPH. The Secretariat of Agriculture and Fishing will have a month from the sanction and publishing of the hereby ordinance to make sensitization campaigns about the production, commercialization and uses of the coconut on the island, as well as this ordinance.

ARTICLE 3. The people who transgress this ordinance will be fined with 5 monthly minimum wage.

ARTICLE 4. The resources collected by these fines must be reinvested in coconut production.

ARTICLE 5. The Secretariat of Agriculture and Fishing must ensure the improvement and technification or areas where coconuts are produced, seeking to raise its output and the adoption of phytosanitary measures.

ARTICLE 6. The hereby ordinance derogates all former ordinances and all dispositions that may be contrary to it. The ordinance hereby is valid once it is sanctioned and published.

Approved at the Hall of Sessions of the Honorable Departmental Assembly, during its ordinary session on July fourteen (14th), two thousand seventeen (2017).
