### **CONSIDERING:**

The period for the post as Administrative Director of the Office of Circulation Control and Residence-OCCRE is of one year.

That according to Article 24 of Decree Law 2762 of 1991, the Director of the office shall be appointed for periods of one year by the Directive Board, from a list submitted by the Governor of the Department Archipelago and may be re-elected.

**ARTICLE FIRST:** Convene professionals of the community who meet the requirements to submit their resumes for election to the Administrative Director of the Office of Circulation Control and residence-OCCRE.

ARTICLE SECOND: DATE, PLACE AND REGISTRATION DOCUMENTS: Candidates to be elected as Administrative Director of the Office of Circulation Control and Residence-OCCRE, must register in person from August 26 to September 10 of this present year, from 8:00 a.m. to 12:00 noon, and from 2:00 p.m. to 6:00 p.m. at the office of the Private Secretariat of the Departmental Archipelago of San Andres, Providence, and Kethleena, and by the email <a href="mailto:privada@sanandre.gov.co">privada@sanandre.gov.co</a>, and attach your resume.

**ARTICLE THIRD:** The Directive Board of OCCRE is convened to carry out the election of the Administrative Director of the Office of Circulation Control and Residence-OCCRE, on September 17, 2021

- 5. Organize exit programs for illegal immigrants from the Archipelago.
- 6. Establish in coordination with the Internal Control Advisory Office, the necessary administrative procedures with their respective control mechanisms to obtain timely quality and coverage in the services that must be attended and efficiency in official procedures.
