Decree No. **0064** (January 29, 2024)

"By means of which the shortlist formed by Resolution Number 009109 of November 15, 2023, for the election of the Director of the Circulation and Residence Control Office - OCCRE, is replaced, and other provisions are adopted."

THE GOVERNOR IN CHARGE OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND SANTA CATALINA, in exercise of their Constitutional, Legal and Regulatory Authorities, especially those conferred by Decree 0063 of 2024, Article 305.2 Constitutional, Article 24 of Decree-Law 2762 of 1991, Article 5.b of the Internal Regulations of the OCCRE - approved by Agreement 001 of 2019, and

CONSIDERING

That by Resolution Number 009109 of November 15, 2023, the Governor in charge selected and integrated the shortlist to elect the Director of the Circulation and Residence Control Office — OCCRE.

That Article 24 of Decree-Law 2762 of 1991, confers on the Governor of the Departmental Archipelago of San Andres, Providence, and Santa Catalina the authority to nominate a shortlist of candidates before the Board of Directors of the OCCRE, for the purposes of electing its director.

That according to Article 5.b of the Internal Regulations of the OCCRE - approved by Agreement 001 of 2019, it is up to its Board of Directors to appoint the director of the OCCRE for periods of one year, from a shortlist presented by the Governor.

That Article 305.2 of the Political Constitution corresponds to the Governor of the Departmental Archipelago of San Andres, Providence, and Santa Catalina, to manage and coordinate the administrative action of the Department.

That the nomination authority of the OCCRE's director is a discretionary, autonomous, and special act of the Governor of the Departmental Archipelago of San Andres, Providence, and Santa Catalina, therefore, it does not create a subjective right or a concrete individual or legal situation in favor of the postulates.

That rooted in the discretion that is dictated by Article 24 of the EJUSDEM Decree-Law, as well as Article 5.b of the Internal Regulations of the Population Control Office, the shortlist formed by Resolution number 009109 of November 15, 2023, will be replaced, exhausting for this is the list of registered professionals, a product of the call that took place between November 2nd and 14th of 2023.

DECREES
