## ORDINANCE Nº 019 OF 2016

(November 29)

"BY MEANS OF WHICH THE GOVERNMENT OF THE DEPARTMENT OF SAN ANDRES, OLD PROVIDENCE AND KETHLEENA IS ORDERED TO INSTALL A WELCOME AND CONMEMORATIVE MONUMENT IN EACH ONE OF THE MAJOR ISLANDS OF THE ISLAND AND ETHNIC TERRITORY".

THE ASSEMBLY OF THE DEPARTMENT ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of its legal faculties, especially the ones given by the articles 13, 47, 54, 68, and 300 of the Political Constitution of Colombia and in accordance to the regulations on the matter, the Law 47 of 1993, the Law 915 of 2004 and the Decree 1222 of 1986,

### **ORDERS**

ARTICLE 1. The Department's Government will install in each of the mayor islands San Andres, Old Providence, and Kethleena of the island and ethnic territory of the Archipelago, a commemorative and welcome monument for all tourists and visitors which will have as main purpose the awareness or inspiration of love each and every person should have towards each of the islands of the Archipelago, just as an additional and catchpenny attraction as a complement to all the tourist infrastructure for tourists, visitors, residents and members of the Raizal Ethnic People.

**ARTICLE 2.** Entrust the Department's Government the compliance of the hereby ordinance.

**PARAGRAPH 1.** The installation must be done guaranteeing the most adequate location, the best setting and impact, according to the importance of its goal and purpose.

**PARAGRAPH 2.** The reflection messages engraved in the commemorative and welcome monuments to be installed, will be oriented to the awareness and inspiration of love each and every person should have towards each one of the islands of the Archipelago for tourists, visitors, residents and members of the Raizal Ethnic People. The message will be: I  $\checkmark$  SAN ANDRES; I  $\checkmark$  PROVIDENCE and I  $\checkmark$  KETHLEENA

**ARTICLE 3.** The hereby ordinance derogates all previous ones to this and all dispositions contrary to it.

**ARTICLE 4.** The ordinance hereby goes into effect from the moment it is sanctioned and published.
