"By means of which the application to participate in the process of Electing the Director of the Circulation and Residence Control Office OCCRE of the Departmental Archipelago of San Andres, Providence, and Santa Catalina Islands is rejected".

THE GOVERNOR IN CHARGE OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND SANTA CATALINA ISLANDS, in exercise of his powers, especially the one conferred by Decree 2762 of 1991, and

#### CONSIDERING

That according to Article 24 of Decree 2762 of 1991, the Director of the Office of Circulation Control and Residence OCCRE will be appointed for periods of one year by the Board of Directors from a short list presented by the Governor of the Departmental Archipelago of San Andres, Providence, and Santa Catalina Islands.

That since the current Director's period ends on September 23, 2022, by means of Decree 0459 of August 8, 2022, the registration period was opened in person or through email address [privada@sanandres.gov.co](mailto:privada@sanandres.gov.co), in order to choose the shortlist for the position of Director of the Office of Circulation and Residence Control OCCRE, providing that any interested professional with defined residence in the Islands, could submit their resume for consideration by the Presidency of the Directive Board, within the period from August 16<sup>th</sup> to August 29<sup>th</sup> of the current year.

The period to put the resumes into consideration has expired, and once the verification of the formal documents of each one of those who were related had been carried out, the presentation of the recommendation of the resume of Attorney ROXANNNE ANGIE WARD BRYAN was evidenced on behalf of the General Coordinator of the Raizal Survival Movement,

That in accordance with Decree 0459 of August 8, 2022, in its Article 2, indicates that the registration will be in person or through email address [privada@sanandres.gov.co](mailto:privada@sanandres.gov.co)

That, due to the foregoing and taking into account that, with the recommendation made as it is not personal, it is considered that there is no certain voluntary manifestation of the application, since it was made through a third party, reason for which the resume will be rejected for not complying with the required procedural requirement.

The registration resume of CAROLINA ALFARO FONSECA, who does not provide defined residence in the Archipelago, is also evidenced, which is why it will be rejected for not complying with the documentation and/or requirements.

In consideration of the above:

**RESUELVE:**

ARTICLE FIRST: Reject the resumes of ROXANNE ANGIE WARD BRYAN and  
CAROLINA ALFARO FONSECA for the reasons stated in motive  
section of this administrative act.


ARTICLE SECOND: By Secretariat, notify the postulates of the decision.
