“By means of which is selected the three candidates for the election of the Director of the Office of Circulation, Control and Residence OCCRE of the Departmental Archipelago of San Andrés, Providence and Ketheena Islands”

THE GOVERNOR IN CHARGE OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND KETHLEENA ISLANDS, in use of his legal faculties, particularly those conferred in Decree 2762 of 1991, and

CONSIDERING

That according to Article 24 of Decree 2762 of 1991, the Director of the Office of Circulation Control and Residence OCCRE will be appointed for periods of one year by the Directive Board, from a list submitted by the Governor of the Departmental Archipelago of San Andres, Providence, and Kethleena Islands.

That due to the fact that the period of the previous Administrative Director of the OCCRE ended on September 23, 2023, it was necessary to establish a shortlist through Resolution No. 007486 of September 13 of the year, which was subsequently dissolved by resolution No. 008873 of November 1 of the same year.

That by decree 787 of the first (01) of November 2023, the registration period was reopened to choose the shortlist for the position of Director of the OCCRE Circulation and Residence Control Office. Providing that any professional with residence defined in the department, could submit their resume for consideration to the President of the Board of Directors, within the period between November 2 and November 14, 2023.
