THE GOVERNOR OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE AND KETHLEENA, in use of his legal faculties and in particular those conferred in Decree 2762 of 1991 and,

CONSIDERING

That through Resolution No. 001454 of April 25 of this present year, election of Representatives of the NGOs was convened to the Directive Board of the Office of Circulation Control and Resident OCCRE.

That having completed the registration period for Representatives to the NGOs to the Directive Board of OCCRE, which was on the twenty-sixth (26th) of April to the fifth (05th) day of May from 8:00 a. m. to 12:00 p. m. and from 2:00 p. m. to 6:00 p. m. , at the Secretariat of Government; there were no enrollment.

That due to the above, it is necessary to RECONVENE to enrollment to carry out the election of Representative by the NGOs to the Board of OCCRE established in the Municipality of Providence and Kethleena Islands.

RESOLVE:

ARTICLE FIRST: Reconvene to registration to carry out the election of Representatives by ONG'S to the Directive Board of the Office of Circulation Control and Residence OCCRE from Wednesday Twenty-fifth (25th) day of May to the first (1st) day of June 2016, on the Island of San Andres, at the Secretariat of Government, from 8:00 a.m. to 12:00 p.m., and from 2:00 p.m. to 6.00 p.m.

ARTICLE SECOND: REQUIREMENTS FOR VOTERS: Each Non-Governmental Organization legally registered with the Chamber of Commerce of the Department, shall exercise their vote through their legal representative, to elect the representative to the Directive Board of OCCRE, or through an elected delegate by the assembly of the organization.
