**RESOLUTION No. 002339
(June 21, 2016)**

"By means of which is selected the three candidates for the election of Director of the Office of Circulation Control and Residence OCCRE of the Departmental Archipelago of San Andres, Providence and Kethleena Islands.

THE GOVERNOR OF THE DEPARTMENTAL ARCHIPELAGO OF SAN ANDRES, PROVIDENCE, AND KETHLEENA ISLANDS, in use of his legal faculties, particularly those conferred in Decree 2762 of 1991, and

CONSIDERING

That according to Article 24 of Decree 2762 of 1991, the Director of the Office of Circulation Control and Residence OCCRE will be appointed for periods of one year by the Directive Board, from a list submitted by the Governor of the Departmental Archipelago of San Andres, Providence, and Kethleena Islands.

That due to the fact that the period of the current Director ends on July 2, 2016, registration period was given to choose the three candidates for the post of Director of the Office of Circulation Control and Residence OCCRE, providing that any professional of the Islands interested, could submit their resume for consideration by the Chair of the Directive Board, within the period from June eight (8th) to June seventeen (17th) 2016.

The closure of the Call took place on June 17, verifying the timely registration of seven (7) resumes.

Upon verification of the formal documents in each resume, it was determined that they comply with the required documentation.
